Atlas General Insurance Services is pleased to provide you access to the National Resource Safety Center (NRSC) library program.

TERMS OF VIDEO LIBRARY USAGE

SHIPPING: All videos will be provided at no rental charge, subject to the terms below by the **above member** and/or sponsoring company for a lending period of twenty-eight (28) days. The twenty-eight-day period begins when the end user receives the videos. All standard DVD orders are shipped Federal Express Ground and requires at least five (5) business days in advance of the requested delivery date. All other requested orders, containing VHS or a combination of VHS and DVD formatted programs, will be shipped Federal Express 2nd Day Air.

RETURNING VIDEOS: As the participating (End User) you are requested to return all programs borrowed directly to NRSC via a service that will provide shipment tracing along with proof of delivery, furthermore **you are responsible for the shipping charges to return the programs to NRSC.** Additionally, videos should be insured for \$400.00 each to ensure that the replacement cost is covered in the event they are lost or damaged in the return shipping.

GRACE PERIOD: You will be allowed a return grace period of up to (10) calendar days beyond the due date of your order. If the program(s) have not been returned to the library by the end of the grace period, the program(s) will be considered lost and you will be billed for the cost to replace the program(s), not to exceed \$200 per lost program. There is a \$50 re-stocking fee for programs returned after the grace period ends.

LOST OR DAMAGED PROGRAMS: You are liable for programs that are returned damaged (other than from shipping). We recommend that you carefully inspect all programs when they are first received. If a program is determined to be damaged, Atlas General Insurance Services and NRSC must be notified immediately. You will be liable for programs not returned on or before the due date or grace period. Any programs not returned (other than being lost in the mail) will be billed to you for their replacement.

RESTRICTIONS: Programs may not be shown where an admission is charged.

NOTE: Federal law provides severe civil and criminal penalties for unauthorized reproduction, distribution or exhibition of copyrighted motion pictures. (Title 17, United States Code, Sections 501 and 506).
